Three main benefits of using a proactive hot spare:

Avoiding "uncorrectable errors" due to media problems during the rebuild process.

Greatly reduce the risk of having a degraded RAID group, and the risk of having a double-faulted RAID group. Performance - a copy to hot spare is faster than a normal rebuild.


